Medically Fragile, Complex and Nursing-Dependent Student Requirements

- X All districts must account for students who have health conditions that require additional nursing services. Oregon law ([ORS 336.201](#)) defines three levels of severity related to required nursing services:
 1. Medically Complex: Are students who may have an unstable health condition and who may require daily professional nursing services.
 2. Medically Fragile: Are students who may have a life-threatening health condition and who may require immediate professional nursing services.
 3. Nursing-Dependent: Are students who have an unstable or life-threatening health condition and who require daily, direct, and continuous professional nursing services.
- X Staff and school administrators, in partnership with school nurses, or other school health providers, should work with interdisciplinary teams to address individual student needs. The school registered nurse (RN) is responsible for nursing care provided to individual students as outlined in ODE guidance and state law:
 - Communicate with parents and health care providers to determine return to school status and current needs of the student.
 - Coordinate and update other health services the student may be receiving in addition to nursing services. This may include speech language pathology, occupational therapy, physical therapy, as well as behavioral and mental health services.
 - Modify Health Management Plans, Care Plans, IEPs, or 504 or other student-level medical plans, as indicated, to address current health care considerations.
 - The RN practicing in the school setting should be supported to remain up to date on current guidelines and access professional support such as evidence-based resources from the Oregon School Nurses Association.
 - Service provision should consider health and safety as well as legal standards.
 - Appropriate medical-grade personal protective equipment (PPE) should be made available to [nurses and other health providers](#).
 - Work with an interdisciplinary team to meet requirements of ADA and FAPE.
 - High-risk individuals may meet criteria for exclusion during a local health crisis.
 - Refer to updated state and national guidance and resources such as:
 - U.S. Department of Education Supplemental Fact Sheet: Addressing the Risk of COVID-19 in Preschool, Elementary and Secondary Schools While Serving Children with Disabilities from March 21, 2020.

- Students who receive services such as reading tutors will work with admin and staff to formulate a plan/schedule.

Visitors/Volunteers:

Visitors/Volunteers will not be allowed to onsite at this time. Adults onsite are limited to only essential personnel.

To this date Harmony doesn't have any students who require additional nursing services. And we are too small to employ a full time nurse.

1c. PHYSICAL DISTANCING

- X Support physical distancing in all daily activities and instruction, maintaining six feet between individuals to the maximum extent possible.
- X Minimize time standing in lines and take steps to ensure that six feet of distance between students is maintained, including marking spacing on floor, one-way traffic flow in constrained spaces, etc.
- X Schedule modifications to limit the number of students in the building (e.g., rotating groups by days or location, staggered schedules to avoid hallway crowding and gathering).
- X Plan for students who will need additional support in learning how to maintain physical distancing requirements. Provide instruction; don't employ punitive discipline.

4 Mixed-Age Classrooms (3-6 years)

Lake Room:
974 sq ft/35 = not to exceed 15 children onsite at one time with a total cohort of 17 (children alternating days) and two adults

Waterfall Room:
933 sq ft/35 = not to exceed 15 children onsite at one time with a total cohort of 17 (children alternating days) and two adults

Ocean Room:
845 sq ft/35 = not to exceed 15 children onsite at one time with a total cohort of 17 (children alternating days) and two adults

River Room:
970 sq ft/35 = not to exceed 15 children onsite at one time with a total cohort of 17 (children alternating days) and two adults

All classrooms will use their own entrance/exit throughout the school day. They will not be in any other part of the building.

The Lake Room, River Room, Forest Room and Waterfall rooms all have their own bathrooms and separate entrance and exit doors. The Ocean Room has their own bathroom directly outside their classroom and will be for their use only.

Any extra tutoring will be conducted in the Mud Room to allow for ventilation and minimum contact with tutors.

Each child will have an assigned seat within the classroom and their own cubbies for their personal items.

Children will eat snacks and lunch in their own classrooms at their assigned seats.

Harmony will develop best practices policy with Multnomah Early Childhood Providers when they return in September.

Harmony has scheduled outside times for each classroom with time in between for sanitizing.

Children will be split into groups and excused in these groups while waiting in line to minimize the waiting time. Physical distancing indicators will show children where to stand. Flow arrows will be on the floors to show them the direction to take when being dismissed, etc.

A letter outlining the instructional model, the rationale and vision behind it and specific infection control measures will be shared with all families through print and electronically when available.

Additional communication regarding protocols will be shared with families and staff in August prior to the start of on-site instruction.

Updated communication will be shared with families at least monthly or as updated information is available throughout the school year.

- X Staff should maintain physical distancing during all staff meetings and conferences, or consider remote web-based meetings.

1d. COHORTING

- X Students cannot be part of any single cohort, or part of multiple cohorts that exceed a total of 100 people within the educational week. Schools should plan to limit cohort sizes to allow for efficient contact-tracing and minimal risk for exposure.

<ul style="list-style-type: none"> <input type="checkbox"/> Direct students and staff to stay home if they, or anyone in their homes or community living spaces, have COVID-19 symptoms, or if anyone in their home or community living spaces has COVID-19. COVID-19 symptoms are as follows: <ul style="list-style-type: none"> ● Primary symptoms of concern: cough, fever (<i>temperature</i> greater than 100.4°F) or chills, shortness of breath, or difficulty breathing. ● Note that muscle pain, headache, sore throat, new loss of taste or smell, diarrhea, nausea, vomiting, nasal congestion, and runny nose are also symptoms often associated with COVID-19. More information about COVID-19 symptoms is available from CDC. ● In addition to COVID-19 symptoms, students should be excluded from school for signs of other infectious diseases, per existing school policy and protocols. Each classroom has a separate entrance/exit. Parents will be involved in the screening process so they may take their child home if there are any symptoms. There is a place on the sign-in/out form to indicate the screening was done before entering the building.</p> <p>Children will go in and directly wash hands. Hand sanitizer is available at each check in site.</p> <p>Screening staff:</p> <p>Each staff member washes their hands directly after entering the building. Takes their temperature and records it along with the date and time. When they sign in they are affirming that they are symptom-free and that they have had no contact with anyone with a confirmed case of COVID-19.</p> <p>Ongoing:</p> <p>Reminders to parents to report actual symptoms when calling students "in sick" as part of communicable disease surveillance. Email all staff and parents link to ODE's Scenario Flow Charts so they can know what will happen if they have contact with COVID-19.</p>

<p>X Screen all students and staff for symptoms on entry to bus/school every day. This can be done visually and/or with confirmation from a parent/caregiver/guardian. Staff members can self-screen and attest to their own health.</p> <ul style="list-style-type: none"> • Anyone displaying or reporting the primary symptoms of concern must be isolated (see section 1i of the Ready Schools, Safe Learners guidance) and sent home as soon as possible. See table "Planning for COVID-19 Scenarios in Schools." • Additional guidance for nurses and health staff. <p>X Follow LPHA advice on restricting from school any student or staff known to have been exposed (e.g., by a household member) to COVID-19. See table "Planning for COVID-19 Scenarios in Schools."</p> <p>X Staff or students with a chronic or baseline cough that has worsened or is not well-controlled with medication should be excluded from school. Do not exclude staff or students who have other symptoms that are chronic or baseline symptoms (e.g., asthma, allergies, etc.) from school.</p> <p>X Hand hygiene on entry to school every day: wash with soap and water for 20 seconds or use an alcohol-based hand sanitizer with 60-95% alcohol.</p>	<p>Do not exclude staff or students who have a cough that is not a new onset or worsening cough (e.g., asthma, allergies, etc.) from school.</p> <p>Parents/guardians can provide information regarding existing conditions that cause coughing to be utilized for the purpose of screening, as previously existing coughs that are not worsening are not considered symptomatic of COVID-19.</p>

<p>X Restrict non-essential visitors/volunteers.</p> <ul style="list-style-type: none"> • Examples of essential visitors include: DHS Child Protective Services, Law Enforcement, etc. • Examples of non-essential visitors/volunteers include: Parent Teacher Association (PTA), classroom volunteers, etc. <p>X Screen all visitors/volunteers for symptoms upon every entry. Restrict from school property any visitor known to have been exposed to COVID-19. Protections under the ADA or IDEA

- X If any student requires an accommodation to meet the requirement for face coverings, districts and schools should limit the student's proximity to students and staff to the extent possible to minimize the possibility of exposure. Appropriate accommodations could include:
- Offering different types of face coverings and face shields that may meet the needs of the student.
 - Spaces away from peers while the face covering is removed; students should not be left alone or unsupervised.
 - Short periods of the educational day that do not include wearing the face covering, while following the other health strategies to reduce the spread of disease;
 - Additional instructional supports to effectively wear a face covering;

- X For students with existing medical conditions and a physician's orders to not wear face coverings, or other health related concerns, schools/districts **must not** deny any in-person instruction.

- X Schools and districts must comply with the established IEP/504 plan prior to the closure of in-person instruction in March of 2020.
- If a student eligible for, or receiving services under a 504/IEP, **cannot** wear a face covering due to the nature of the disability, the school or district must:
 1. Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan including on-site instruction with accommodations or adjustments.
 2. Placement determinations cannot be made due solely to the inability to wear a face covering.
 3. Plans should include updates to accommodations and modifications to support students.
 - Students protected under ADA/IDEA, who abstain from wearing a face covering, or students whose families determine the student will not wear a face covering, the school or district must:
 1. Review the 504/IEP to ensure access to instruction in a manner comparable to what was originally established in the student's plan.
 2. The team must determine that the disability is not prohibiting the student from meeting the requirement.
 - If the team determines that the disability is prohibiting the student from meeting the requirement, follow the requirements for students eligible for, or receiving services under, a 504/IEP who cannot wear a face covering due to the nature of the disability,
 - If a student's 504/IEP plan included supports/goals/instruction for behavior or social

Harmony recognizes it may be difficult for young children to wear cloth face coverings for long periods of time or because of sensory or other needs. Families are asked to contact their teacher or the Head of School to make a plan for breaks throughout the day. (Examples: a support teacher taking a child outside for breaks, a designated chair placed well away from others for 15 minute breaks while wearing a face shield.) A teacher will remain in sight of any child taking a break from cloth face coverings.

The teachers will continue to give lessons on proper cloth face covering protocol to their students.

Admin will continue to send out reminders about cloth face covering hygiene.

Harmony will provide child-sized cloth face coverings for all children who come to school without one. And has offered extras to any family that doesn't have access to them.

 - The symptomatic student should be seated in the first row of the bus during transportation, and multiple windows should be opened to allow for fresh air circulation, if feasible.
 - The symptomatic student should leave the bus first. After all students exit the bus, the seat and surrounding surfaces should be cleaned and disinfected.
 - If arriving at school, notify staff to begin isolation measures.
 - If transporting for dismissal and the student displays an onset of symptoms, notify the school.
- Consult with parents/guardians of students who may require additional support (e.g., students who experience a disability and require specialized transportation as a related service) to appropriately provide service.
- Drivers wear face shields or face coverings when not actively driving and operating the bus.
- Inform parents/guardians of practical changes to transportation service (i.e., physical distancing at bus stops and while loading/unloading, potential for increased route time due to additional precautions, sanitizing practices, and face coverings).
- Face coverings or face shields for all students in grades Kindergarten and up following [CDC guidelines](#) applying the guidance in section 1h of the **Ready Schools, Safe Learners** guidance to transportation settings.

2j. CLEANING, DISINFECTION, AND VENTILATION
